

CarbonTV's 2017 Fishing Stars Hunting Stripes Sweepstakes

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **Eligibility:** CarbonTV's "Fishing Stars Hunting Stripes Sweepstakes" (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (and the District of Columbia), who are at least eighteen (18) years old at the time of entry. Employees of Carbon Media Group, N.O.D.R., Girls With Guns TV, and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, provincial, municipal, territorial and local laws and regulations and is void where prohibited by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. The Sweepstakes consists of seventeen daily entry periods (each "Daily Entry Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
4. **How to Enter:**
 - a **Register or login to CarbonTV.com:** During the Promotion Period, visit <http://www.carbontv.com/sweepstakes> ("Website") and watch the video and then sign up for a free CarbonTV account, by completing and submitting the registration form and clicking on the "Sign Up and Enter" button. You automatically will receive one (1) entry into the drawing. If you already have an account or once you have registered for an account during the Promotion Period, you can receive additional entries by returning to the Website each day, watching the video and clicking on the "Enter to WIN" button. **Limit:** Each participant may **enter one time per Daily Entry Period during the Promotion Period**. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, CarbonTV accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder. If prompted to provide personal data of a friend, including email address, you must have consent of your friend to do so.
 - b **Earn Bonus Entries:** Earn up to a total of **five (5) additional entries per Daily Entry Period**.

5. **Drawings:** Sponsor's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Sponsor will randomly select the potential Sweepstakes winners from all eligible entries received during the entry period on or around August 10th, 2017. The potential winner will be notified by email and asked to provide a valid mailing address for prize fulfillment purposes within three (3) days of the date notice or attempted notice is sent, in order to claim his/her prize. Receiving a prize is contingent upon compliance with these Official Rules. If a potential winner cannot be contacted, fails to provide the requested information or to answer the skill testing question correctly (if applicable) within the requested time period, or prize is returned as undeliverable, potential winner forfeits the prize. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prizes should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use. Disputes:** Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan U.S.A. (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
