

CarbonTV's "Merica Madness" Sweepstakes

- 1. Eligibility:** CarbonTV's "Merica Madness" Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (and the District of Columbia), who are at least eighteen (18) years old at the time of entry. - 4. How to Enter:** During the Promotion Period, visit <http://www.carbontv.com/sweepstakes> ("Website") to sign up for a free CarbonTV account, by completing and submitting the registration form and clicking on the "Sign Up and Enter" button. You automatically will receive one (1) entry into the drawing. If you already have an account or once you have registered for an account during the Promotion Period, you can receive additional entries by returning to the Website each day and clicking on the "Enter to WIN" button. **Limit:** Each participant may enter one time per Daily Entry Period during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, CarbonTV accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.
