

The CarbonTV Huntin' Fool Sweepstakes

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The CarbonTV Huntin' Fool Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (and the District of Columbia) and Canada (excluding Quebec), who are at least eighteen (18) years old at the time of entry. Employees of Carbon Media Group and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, provincial, municipal, territorial and local laws and regulations and is void in Quebec and where prohibited by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. 3. Timing: The Sweepstakes begins on August 1, 2015 at 12:00 p.m. Eastern Time ("ET") and ends on September 1, 2015 at 11:59 a.m. ET (the "Promotion Period"). The Sweepstakes consists of thirty-one daily entry periods (each a "Daily Entry Period") starting at 12:00 p.m. and ends at 11:59 a.m. the following day. Sponsor's computer is the official time-keeping device for the Sweepstakes.

4. How to Enter: During the Promotion Period, visit www.carbontv.com/sweepstakes ("Website") to sign up for a free CarbonTV account, by completing and submitting the registration form and clicking on the "I Want to WIN" button. You automatically will receive one (1) entry into the drawing. If you already have an account or once you have registered for an account during the Promotion Period, you can receive additional entries by returning to the Website each day and clicking on the "I Want to WIN" button. Limit: Each participant may enter one time per Daily Entry Period during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, CarbonTV accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder. If prompted to provide personal data of a friend, including email address, you must have consent of your friend to do so.

Receive Additional Entries by Telling your Friends: You can earn additional entries by sharing your participation in this Sweepstakes with your friends through email, Facebook, Google+ and Twitter, as well as watching an on-page video to completion. After you enter the Sweepstakes, you will be invited to submit the names and valid email addresses of friends who must be eligible to enter the Sweepstakes (***you only need to include one email address to get an extra entry***). Each person that you refer will receive an email notifying them about the Sweepstakes. You may only refer persons with whom you have an existing relationship. Alternatively, you may share on Facebook, Google+ or Twitter by using the prepopulated message provided by Sponsor. For each referral method you use, as well as watching an on-page video to completion, you will be given one (1) additional entry into the applicable Daily Entry Period drawing up to a total of five (5) additional entries per Daily Entry Period.

5. Drawings: Sponsor's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Sponsor will randomly select the potential Sweepstakes winners from all eligible entries received during the entry period on or around September 10th, 2015. The potential winner will be notified by email and asked to provide a valid mailing address for prize fulfillment purposes within three (3) days of the date notice or attempted notice is sent, in order to claim his/her prize. If any potential winner is a Canadian resident he/she will also be required to answer a time limited skill testing question without assistance, in order to be eligible to receive a prize.
