

Eligibility: The “Ladies Only CarbonTV Turkey Hunt Giveaway” (the “Sweepstakes”) is open only to legal residents of the United States who are twenty one (21) years of age or older at the time of entry. Employees of CarbonTV or other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations and is void in Puerto Rico and where prohibited by law.
