

**CarbonTV-Kryptek Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The CarbonTV - Kryptek Sweepstakes (the “Sweepstakes”) will take place July 22, 2019 through December 31, 2019 (the “Sweepstakes Period”). The Sponsor’s database computer is the official time-keeping device for this Sweepstakes. By entering the Sweepstakes, you accept and agree to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects.

ELIGIBILITY: The Sweepstakes is open to legal residents of the United States who are at least eighteen (18) years old (or the age of majority in the applicable jurisdiction, whichever is older) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child, or sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Sponsor¹ and its parents, affiliated companies, subsidiaries, representatives, agents, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies and persons associated with the Sweepstakes (collectively, the “Sweepstakes Entities”) are not eligible to participate or win the Prize. The Sweepstakes is subject to all applicable federal, state, and local laws, rules and regulations. Void where prohibited by law.

HOW TO ENTER: To enter, visit the website, www.carbontv.com (the “Website”) and follow instructions to complete the entry process by providing the information requested. Any information you submit will be subject to the Website’s privacy policy. All entries must be received during the Sweepstakes Period in order to participate. Limit one (1) entry per person, per day. Subsequent entries from the same person may be disqualified. Any attempt by a person to enter more than once may result in disqualification at the discretion of the Sponsor. No other methods of entry will be accepted.

DRAWING AND WINNER NOTIFICATION: The winner of the Sweepstakes drawing will be randomly selected by the Sweepstakes judges from all eligible entries received throughout the Sweepstakes Period. The random drawing will be conducted on or about December 31, 2019. The potential winner will be notified by telephone and/or email and/or mail using the contact information provided at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If the potential winner does not respond within seven (7) days after the first notification attempt, or if the Prize or Prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected. If any potential winner is found to be ineligible, or if she or he has not complied with these Official Rules or declines the Prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected.

PRIZE/ODDS: One (1) prize will be awarded: 2019 Chevrolet Trail Boss customized by CarbonTV and Kryptek (ARV: \$85,000) (the “Prize”). Customization of the Prize is in the sole discretion of the Sponsor. No cash alternative or prize substitutions will be allowed, except in Sponsor’s discretion. Sponsor may award a substitute prize of comparable or greater value if the Prize becomes unavailable for any reason.

Odds of winning will depend on the number of eligible entries received.

The winner is responsible for the payment of all taxes. The Prize is non-transferable, non-negotiable and not redeemable for cash. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten, or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

In the event of a dispute as to the identity of the entrant, any entry will be deemed submitted by the authorized account holder of the e-mail account from which it was sent, provided such account holder must still meet the eligibility requirements for the Sweepstakes. The authorized account holder shall be the natural person to whom the applicable email address has been assigned by the Internet access provider, service provider, or other online organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, in whole or in part, if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures, malfunctions or other unintended circumstances have impaired the integrity, administration, security, proper play, and/or feasibility of the Sweepstakes as contemplated herein. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select winners in a random drawing from all eligible, non-suspect entries unaffected by the problem. Inclusion in such drawing shall be each entrant's sole and exclusive remedy in such circumstances.
